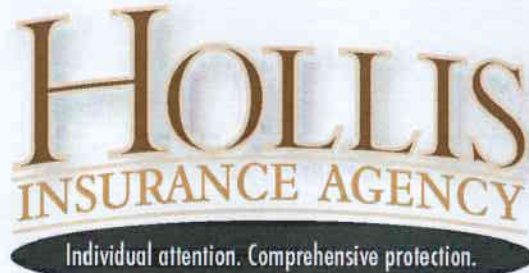

2. Falls
3. Water Damage
- 4 Theft, burglary, vandalism

6. Lightening & electrical
